Significant Accomplishments:

- New student applications have increased by 44 percent, from 800 to 1150, over three years as a result of new strategic planning and marketing efforts.
- New student registrations have increased by 22 percent, from 320 to 390+, over three years.
- Provided leadership to successful completion of NTID's second capital campaign, which raised \$26.9 million, surpassing our goal by 4 percent.
- Vocational Rehabilitation support for NTID students has increased 23 percent over the past two years to \$8.1 million in FY 2009.
- Increased NTID faculty/staff participation in the campaign from 36 percent to 72 percent in 2006.
- Increased the number of endowed scholarships from 68 to 75 through 2006.
- Increased website traffic by 72 percent from 2006-2009. More than 93,000 visitors viewed the NTID website, 59,000 of them being external visitors who are prospective students, parents, employers or media members.
- NTID placement rate for 2008 graduates increased to 93 percent. This is the target approved by the U.S. Department of Education.
- Provided oversight and administrative leadership to the development and implementation of NTID's pre-college outreach effort, which was one of Strategic Vision (SV) 2010's four major goals for 2005-2010. Ten outreach projects servicing more than 600 pre-college Deaf and hard-of-hearing students were implemented during this period. These

educational outreach activities are designed to enhance career education preparation of Deaf students along with their interest/awareness of RIT/NTID. These educational outreach activities provide a pipeline of qualified students for NTID's future.

- Established media e-news, which grew to more than 1,000 subscribers from 2006-2007.
- Established and directed NTID's Military Veterans with Hearing Loss Project.

Grants

This grant was awarded by the United States Department of Education to establish a Northeastern Technical Assistance Center.

This grant was received in 1995 for a total of \$5 million over five years. The grant has been renewed with modifications two times and will have resulted in bringing \$15 million to NTID over 15 years.

United States Department of Education Author: Gerard Buckley

This grant was awarded by the United States Department of Education's Office of Special Events (OSEP) to establish a statewide system for electronic dissemination of information to Deaf and hard-of-hearing citizens of Kansas

The grant was awarded to Johnson County Community College (JCCC) in 1989 for three years for a total of \$315,000. This grant electronically linked leaders in the Deaf community with service providers via DeafNET in the early 1990's. It also provided text pages to Deaf and hard-of-hearing individuals for the purpose of enhancing communication on the job.

Kansas State Education Department Grant Authors: Gerry Buckley and David Rosenthal

This grant was awarded by the Kansas State Education Department (SED) through Rehabilitation Services to provide career education services to Deaf and hard-of-hearing students in Kansas. The grant was awarded annually from 1983-1990 at \$53,000 per year for a total of \$399,000.

The grant provided support for career education classes at the Kansas School for the Deaf, JCCC, and for a statewide weekend program of activities for Deaf students and their families.

This grant was awarded from 1986-1989 to JCCC to support the establishment of a pilot Adult Basic Education (ADE) program for Deaf and hard-of-hearing residents of Kansas. \$30,000 dollars over three years was provided to support ADE classes taught by Deaf instructors.
